- Healthcare systems in more than 65 countries and regions are implementing GS1 standards—in Australia, Brazil, Europe, Japan, Korea, New Zealand, Saudi Arabia, UK, United Arab Emirates, U.S. and many more.<sup>1</sup>
- Today, nearly all EU countries are using GS1 standards to identify pharmaceutical products in support of the EU Falsified Medicines Directive.<sup>2</sup> The Department of Health in England is driving the implementation of GS1 standards throughout its NHS Trusts.<sup>3</sup>
- As of June 2017, more than 85 percent of medical device records loaded into the U.S. Food and Drug Administration's Global UDI database are using GS1 standards as the primary identifier.<sup>4</sup>
